## Subject: Product Change Notice

Dear Telit Partner,

The following products will be updated as of September 2011:

## C24 / G24 / G24-L / G30 / H24

The labels have been changed to reflect that these modules are now Telit products.

Due to regulatory requirements, they will have a new Logo and a new CE mark. This was a paperwork exercise only with no hardware changes or additional testing required.

As regards the North American market, FCC and IC approvals for Motorola modules have been transferred to Telit under new IDs that are also updated on the label. Any products that reused the Motorola FCC and IC IDs based on previously verified performance conformity in terms of the Grant/certification must have an updated label to reflect new IDs..

A readily visible label is required on the outside of the host that states "FCC ID: RI7xxxx/IC: 5131A-xxx is contained within" (where xxx is the appropriate product code/model of the module). The label must not be removed from the embedded module

The updated module labels will reflect the new FCC and IC IDs as follows:
